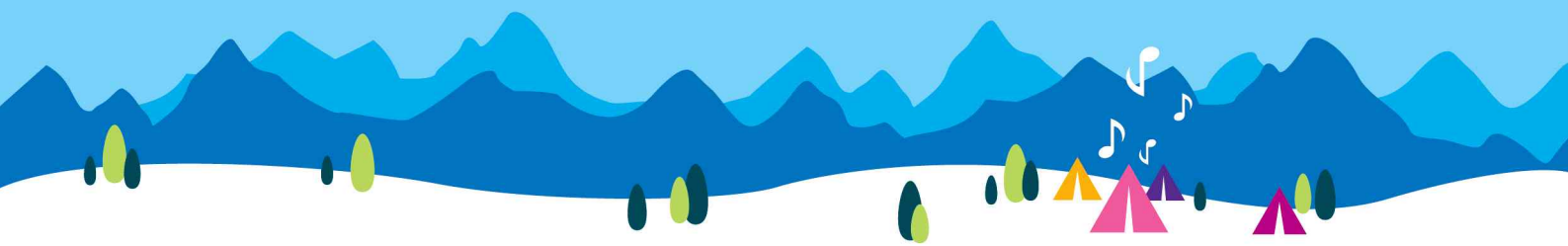

1. Contingent Tent (including contingent exhibition) Registration

Based on feedback we received during the recently held Heads of Contingent Meeting, a decision has been made to reopen the submission process for a limited period of time (until June 15, 2023)

If your Contingent has already submitted the form and your Contingent is included in the list below, your application has been received and there is no need to resubmit it. However, if your Contingent is not listed, please ensure to submit or resubmit the Contingent Tent Application Form.

Please be advised that it is mandatory for your Contingent to organize and present an interactive, lively, and engaging exhibition in order to be eligible for the allocation of a Contingent Tent. This requirement must be clearly described in the Contingent Tent Application Form. If any additional information is required regarding your application, our team will contact you directly.

Each power outlet will allow you to draw an absolute maximum of 1400 watts (1.4KW). Outlets will be standard Korean outlets (Plug Type C), 220V and 60Hz. Please bring adaptors, if needed.

All tents will have non-see-through sides on all four sides, unless put together, then only the outer sides will have sides attached. You can open the tent as you see fit during opening hours. Where several tents are put together, rain gutters will be installed between tents. There will be no flooring in the tent unless you have rented it for an additional cost.

A reminder, you are not allowed to paint, draw or otherwise permanently decorate the tents. Using duct tape or similar adhesive tape to attach things to the tent wall is not allowed, as the glue in the tape can damage the tent. We suggest you hang decoration, boards etc. using rope, zip ties or strings from the steel construction that the tent has.

We will provide a Shared Office Space for Contingents to conduct administrative business in case your Contingent does not have its own Contingent Tent. In the Shared Office Space, there will be tables, chairs, and internet connectivity. Setup in a fly-in style.

We have included 'Contingent Tent Application Form'(Appendix 20-1), to this circular, which is the form you will need to submit. It was originally published in [Circular #6](#).

The form must be submitted before **June 15 2023** via mail to wsjexhibition@scout.or.kr.



2. Updated Rental List

The provided list includes new items, removed items, and updated prices for each item. We kindly request you to consider these changes while reviewing the list.

Although you may have previously submitted a rental list, due to the substantial number of modifications made, we kindly ask you to **resubmit the rental list using the new version**. We will only be able to fulfill rental requests based on the items listed in the new list. We apologize for any inconvenience caused.

If you have any changes to make to the rental list, please resubmit the updated version, ensuring that it includes the totals for each item you wish to rent. We aim to have only one list per Contingent, and we will solely rely on the most recent list that has been submitted.

Please ensure that the updated rental list reaches us no later than **June 15, 2023**, by sending it to wsjexhibition@scout.or.kr. Any forms received after this date will not be processed.

3. Payment

All the items listed are being supplied by Seoul Tent, an external company. We will promptly share your rental orders with Seoul Tent after the deadline. You will receive an invoice directly from Seoul Tent via email, and you will be responsible for making the payment directly to Seoul Tent.
